**HR.962/S.311** (replaces S.130) the *Born Alive Abortion Survivors Act* has twice failed to get the needed 60 votes in the Senate. There have been 80 failed tries to vote on it in the House. GOP House members drew up a Discharge Petition, **H.Res.102**, to force a vote on the bill. As of Dec. 5, the Petition is still 15 shy of the needed 218 signatures. All Senate Democratic Presidential hopefuls voted NO on **S.311**.

Anti-Life Bills that have been introduced in Congress:

**HR.1581/S.707**- *Reproductive Rights are Human Rights*

**HR.1692/S.758** - To end almost all abortion restrictions

**HR. 2975/S.1645** - *Women's Health Protection Act*

**HR.5/S.788**, the *Equality Act*, (conscience and religious liberty concerns) passed the House, but not the Senate.

Backers have introduced six "piecemeal" versions of HR.5. A House source says they're unlikely to become law. The bills are: **HR.1244/S.515**, **HR.1450**, **HR.2687**, **HR.3294/S.1940**, **HR.2480** & **HR.3299** (the last two passed in the House) [See LN Jul/Aug 2019, p3]

Executive Orders, Agency Rules & Court Challenges

In 2016 SCOTUS (*Zubik v. Burwell*) asked lower courts to settle disputes over the HHS abortifacient/ sterilization/ contraceptive mandate. They have not. Executive Orders and HHS Regulations were issued to protect religious & moral objectors (non-profits and small business). Twenty-one states sued to block the regulations. The 9<sup>th</sup> Circuit ruled for the states. It will again be up to SCOTUS.

**The DC Circuit Court of Appeals** ordered the Office of Refugee Resettlement to facilitate abortions for minor unadmitted immigrants in Federal custody (June 2019). **Three 5<sup>th</sup> Circuit judges** said Texas can ban Medi-

icaid funds from going to PP (Jan 2019). Previously, SCOTUS appeared to say individuals can sue a state for doing that.

**HHS** rules to protect conscience of healthcare workers/ providers were to begin Nov. 22, but following lawsuits, were blocked nationwide by NYC Judge Engelmayer. The HHS is set to modify ObamaCare Sec 1557, which calls refusal to perform abortion "sex discrimination." In Oct. a Texas judge ruled in favor of the change. The HHS issued regulations compelling insurers to clearly show if policies cover abortions. HR.20 would do the same. The Conscience & Religious Freedom Division of HHS's Office of Civil Rights received 343 complaints of religious or moral discrimination in 2018. HHS's *Protect Life Rule* says any group that does abortion and gets *Title X* 'family planning' funds must do abortions in a separate facility, not paid for by *Title X*. In July, the full 9<sup>th</sup> Circuit upheld the rule. PP and 875 other groups chose to stop taking *Title X* funds. The rule bans abortion referral (not discussion) by *Title X* recipients. In 2017, HHS changed the Teen Pregnancy Prevention grant program to stress sexual risk avoidance. In June 2018, PP and others sued. TPP still funds abstinence. HHS reminded hospitals that *the Emergency Medical Treatment & Labor Act*, and the *Born-Alive Infant Protection Act* (of 2002) require abortion or miscarriage survivors to receive treatment (July 2019).

**Secretary of State Pompeo**: no foreign aid funds to groups that pay other groups that do abortions (May 2019). The three last *State Dept. Annual Human Rights Reports* have not listed abortion as a human right. In addition, abortion is not promoted internationally as 'healthcare'. **The Dept. of Labor** released new rules (8/15/19), making it clear Federal contractors can use reasons of conscience in their decisions to hire or fire workers.

## NEW YORK STATE LEGISLATION



Gothamist.com (11/8/19) lamented that the **RHA bill** has not made 3<sup>rd</sup> trimester abortions easier to obtain in NY, claiming PP and ParkMed limit abortions (24 & 26 weeks respectively). Guttmacher states there were 1100 such abortions in NYS in 2017. At the Nov. 25 LICL meeting, it was noted that 1700-2000 late term abortions are done yearly in NY, as *Roe* and *Doe* have allowed third trimester abortions since 1973, despite state laws.

**The 'Boss Bill'**, S.660-Metzger/A.584-Jaffee, signed by Gov. Cuomo, could force religious entities to hire people opposed to the group's basic religious beliefs.

**Medical Aid in Dying - Physician Assisted Suicide** will be pushed in the new legislative session.

## HEALTH & SCIENCE

### The Future of Abortion



Jim Sedlak, executive director of American Life League and founder of Stop Planned Parenthood International wrote in the Wednesday 12/4/19 STOPP report, “We all need to understand that, whatever the annual abortion numbers coming out of the CDC or Guttmacher are, the future of abortion in America is NOT the surgical or birth control buildings at which we pray, counsel, protest and mourn. The future is the at-home, self-managed abortions that are already taking place daily and will escalate as quickly as we will let it...I [Sedlak] first found out that so-called contraceptives actually end the lives of preborn babies when Planned Parenthood told me in 1986. That’s right, the other side has always known that contraceptives kill human beings in the womb. They just cleverly manipulated definitions so that killing those babies was not called an abortion.”

About 90% of the so-called contraceptives on the market today actually result in the death of a pre-born baby. Most contraceptives act in one of three ways: prevent ovulation, prevent fertilization or prevent implantation. Preventing implantation results in the death of the embryo. ‘Self-managed’ at-home medical abortions are done using the abortion pill regimen: Mifepristone or Methotrexate is taken to kill the developing child. A second drug, misoprostol, is then taken causing contractions to expel the child from the womb. These abortion pills are now available online. Sedlak stated, “If we do not, as a community, expand our fight in 2020 to include the protection of every human being facing death after he or she is created, we will be destined to lose the war.”

#### “My body, my choice,” – The Pro-Life Response:

Brian Clowes, PhD, wrote at Human Life International (5/27/18), “To begin with, it is impossible to reply directly to this slogan unless we have the user clarify what he or she means by it. We need to ask, “Why do you consider the unborn child to be a part of the woman’s body?” The usual response is a momentary hesitation, followed by one of three possible answers: the fetus relies on the mother completely for its existence, the fetus is inside her body, therefore it is part of her body, or the fetus is a parasite.”

Pro-abortionists argue that since the unborn child is totally dependent upon the mother, she has a “right” to dispose of the baby. Clowes states that these arguments must be treated separately. A newborn child is just as dependent as a pre-born child and requires care to survive. Can a newborn be neglected or killed outright? Pro-abortionists argue ‘yes’ in the debate regarding infanticide after a ‘failed’ abortion. Some have been arguing for years that it is acceptable to allow disabled children to die after birth. This is referred to as “fourth-trimester abortion” or “post-natal abortion”.

Nobel Prize winner Dr. Francis Crick stated, “no newborn infant should be declared human until it has passed certain tests regarding its genetic endowment...if it fails these tests, it forfeits the right to live.” Clowes states, “The pro-life answer is simple rebuttal. Every child who is born healthy is already entitled to care under the pain of prosecution for murder. And that baby, too, is completely dependent, so the argument is a non sequitur.”

Pro-abortionists argue that since the pre-born child is inside the mother, the child is part of her body. Clowes provides an analogy regarding astronauts: they are totally dependent on their vessel for air, water food, etc. If they exit the vessel without protection, they will die. “This holds true for a nonviable unborn baby. Yet no thinking person would argue that the astronauts are part of a space station!”

Clowes argues that pro-abortionists may often need to dehumanize the pre-born child to assuage their guilt, which may lead to them to label the fetus a parasite. Abortionist Warren Hern wrote in his book *Abortion Practice*, “The relationship between the gravid female and the fetoplacental unit can be understood best as one of host and parasite.” Clowes responds, “When pro-abortionists insist that the unborn child is a parasite, they are acknowledging its separate nature, because parasites are never part of their host’s body. They are biologically separate and distinct organisms. Anyone denying this fact is simply being anti-scientific.” Clowes further asks if they would consider a tapeworm part of their body.

#### Woman and Child: Separate Bodies, Separate People

Clowes states, “If an unborn child were part of its mother’s body, it would share all of her biological characteristics. Yet the baby even has its own distinct DNA.” He argues that “not even the most ignorant pro-abortionist can deny:

\*All mothers are obviously female. About half of their children are male. How can a human being be both male and female?

\*The mother and baby frequently have different blood types.

\*The baby can be a different race from the mother.

\*Every cell in the mother’s body has a set of chromosomal characteristics that is entirely distinct from every cell in the baby’s body.

\*When the unborn child anchors to the uterine wall, there is a concerted attack by white blood cells to defeat him, and he must defend himself. The mother’s immune system recognizes it as “non-self.” Therefore, it is not part of her body.

\*The baby can die without the mother dying. The mother can die without the baby dying (the baby can be rescued if he is viable).

\*The unborn baby initiates a process that culminates in its leaving the mother’s body. Challenge a pro-abortionist to name any other body organ that does this.”

Clowes concludes, “Pro-lifers agree that a woman does indeed have the right to manage her own health. However, maintaining that right does not allow the mother to destroy her child’s body. When she conceived, she had already passed the right to life on to that new life.”

After declaring that “The Salvation Army accepts the moment of fertilization as the start of human life” the organization then affirms and supports the need for abortion. “The Salvation Army believes that life is a gift from God and we are answerable to God for the taking of life.” We do not believe that genetic abnormalities that are identified in an unborn child who is likely to live longer than a brief period after birth are sufficient to warrant a termination of pregnancy.

The Salvation Army recognizes tragic and perplexing circumstances that require difficult decisions regarding a pregnancy. They believe that termination can occur only when:

Carrying the pregnancy further seriously threatens the life of the mother or reliable diagnostic procedures have identified a fetal abnormality considered incompatible with survival for more than a very brief post-natal period. In addition, rape and incest are brutal acts of dominance violating women physically and emotionally. This situation represents a special case for the consideration of termination as the violation may be compounded by the continuation of the pregnancy.
